General information

- **Changes of the EORI HHLA container terminal Burchardkai**

As part of the implementation of the new branch concept of the German customs (“Niederlassungskonzept”) the EORI of the CTB will be changed on 27.06.2018:

	EORI	Branch
Currently	DE7831005	0000
As of 27.06.2018	DE7049293	0001

With this newsletter we would like to provide answers to the most important questions regarding the effects of the conversion on IMP:

When does the conversion take place?

The conversion of the EORI is carried out by the system in ATLAS on 27.06.2018 shortly after midnight. Within the application IMP a release update is carried out on 26.06.2018 in order to avoid additional system interruptions. Experience so far has demonstrated that you can reckon with a timeframe until 0:30 a.m.

How does the conversion affect the interfaces? Are there any software modifications?

No! Internally IMP does not use the EORI of the CTB, but the terminal code (BK9). The assignment will be changed accordingly in the IMP configuration.

Of course the EORI and branch number within the field “Depository” in the status message to the summary declaration are changing. Please keep it in mind if you want to read it out and process it internally.

Does preliminary ATB-numbers, generated before the conversion, remain unchanged?

Yes, a preliminary ATB-number remains valid after the conversion, also the period of 30 days within which you have to confirm it.

What about containers which are already in temporary storage?

After the conversion, IMP will automatically pull the storages to the new EORI and branch number by carrying out a change of temporary storage. Subsequently you will receive the status message „934 – ATB confirmed“.

What impact does this have on landside deliveries?

In case of landside deliveries in temporary storage it is important to recognize at which time it has been notified. In this case “notify” means that before the delivery at the terminal the truck driver, carrier, importer or the depository, specifies the terminal as authorized to dispose in the summary declaration.

- Notification before the conversion
The status 946 is at hand, the storages are automatically pulled to the terminal at delivery. Additional measures are not required.
- Notification after the conversion
Please make sure to specify the EORI „DE7049293“ **including the branch number „0001“** as person authorized to dispose. **Especially if you overlook the branch numbers the message cannot be assigned to the CTB and therefore not been taken into temporary storage at delivery!**
