General information

▪ Change of login module

In the course of the changeover to a standardized login module the login data of several DAKOSY applications are brought together. Conflicts may occur if the same user name within a company is used twice within two different applications. In case you use one of the following DAKOSY products, beside IMP-Direct, in the future you have to use the login data of this application, since your previous password from IMP-Direct will not be accepted anymore:

If you, for example, use the applications IMP and PRISE and created a user account for mueller within both systems, the password from PRISE remains unchanged and now also applies for IMP-Direct:

■ Additional information within the XML status message 1.5.4

As of now the terminal status, container movement status and ZAPP status will also include vessel data.

In case of Status:"915= new ETD" the ETD will not only be transmitted within the text field, but also within the segment <StatusDate> .

■ New elements within the XML status message 1.5.4

As already announced in the newsletter 5/2018, the following changes are now being activated: Status messages based on information of the veterinary and import office include the list of CVED numbers for the goods stored in the container, if available.

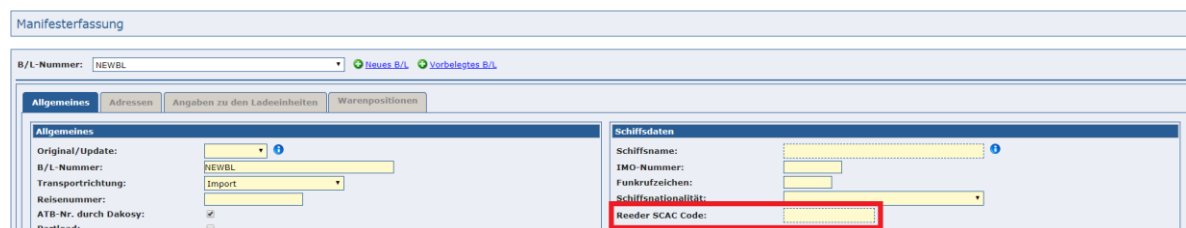

These numbers will be transmitted within the element „VeterinarianDataList“. Also new is the element „StatusConfirmedByVeterinaryOffice“ in case of status 927 (goods are veterinary relevant). In the future you may receive the status determined by the IMP and one more time confirmed by the veterinary office.

▪ Entry of carrier's SCAC code

The new field „Carrier's SCAC code“ has been added within the manifest entry below the tab „General“ in the area vessel data. You can enter the SCAC code manually or enter a carrier via the dropdown menu.
