With the ZAPP Circular no. 55 we would like to inform you about the replacement of the HDS/GM01 interfaces by the Port Order XML message and about important changes important changes in connection with the ATLAS re-export control system (WKS).

1. Deactivation of the HDS/GM01 interfaces as of 01.01.2027

The replacement of the HDS and GM01 interfaces by the Port Order XML interface is ongoing. Various customers have already been switched to the new interface. In addition many transport system providers work on the implementation of the new interface.

DAKOSY will provide the **HDS and GM01 interfaces until the 31.12.2026** to guarantee a sufficiently long period of time for the implementation of the Port Order XML interface and the conversion to the new format.

New customers shall solely be connected to the **Port Order XML format as of 01.07.2026**. This dates apply for the input interface for the transmission of Port Order data to DAKOSY.

Please inform your transport system provider about this dates, if necessary.

2. Update regarding the WKS migration

The webpage <u>zoll.de</u> (status as of 21.8.2025) states the following regarding the replacement of the ASumA in EAS by the re-export control system (WKS): "Die ASumA im Verfahren EAS wird durch die ASumA in WKS abgelöst. In einer Übergangsphase, die am 30. Juni 2026 endet, wird die ASumA in beiden Verfahren unterstützt. Nach diesem Termin können Neuanmeldungen nur mehr in WKS erfolgen. Die Weiterbearbeitung von Bestandsvorgängen in EAS ist auch über diesen Termin hinaus zunächst noch möglich."

(The ASumA in EAS will be replaced by the ASumA in WKS. During a transition period ending on the 30th of June 2026, ASumA will be supported in both procedures. After this date new declarations can only be carried out in WKS. The further processing of already existing processes in EAS will still be possible for a while.)

Currently DAKOSY starts with integration tests for the WKS connection from ZAPP/EMP.

We are still working on a new time schedule for the migration from EAS to WKS via ZAPP/EMP. As soon as the planning is finalised we will inform you in a separate ZAPP circular.

2. Interchange adaptations of WKS

In the ZAPP Circulars <u>no. 48</u> and <u>no. 49</u> we informed you about necessary interface changes in preparation for the re-export system (WKS). Theses interface changes still must be implemented promptly.

The additional data is mandatory for the ASumA declaration in ATLAS WKS and can already be received by the DAKOSY test and productive environments.
